
WHEREAS, pursuant to proper notice duly given as required by law, the Carlos Town Board of Supervisors has met and heard and passed all objections to the proposed assessment for the improvement of Carlos Timbers East by bituminous surfacing.

NOW THEREFORE, BE IT RESOLVED BY THE CARLOS TOWNSHIP BOARD OF SUPERVISORS, DOUGLAS COUNTY, MINNESOTA;

- 1) Such proposed assessment, a copy of which is attached hereto and made a part of hereof, is hereby accepted and shall constitute the special assessment against the lands named therein, and each tract of therein included is hereby found to be benefited by the proposed improvement in the amount of the assessment levied against it.
- 2) Such assessments shall be payable in one of two ways: paid in full to the clerk on or before November 25, 2018; or by installments extending over a period of 5 years, the first of the installments to be payable on the residents property taxes beginning in May 15, 2019 and shall bear an interest of 8 percent per annum from January 1, 2019. To each subsequent installment when due interest will be added for one year on all unpaid installments.
- 3) At any time during the 5 year time span, the resident may contact the clerk and pay off the full remaining balance with no interest to be charged the remaining years.
- 4) The clerk shall forthwith transmit a certified duplicate of this assessment to the county auditor to be extended on the property tax list of the county. Such assessments shall be collected and paid over in the same manner as other municipal taxes.




WHEREAS, pursuant to proper notice duly given as required by law, the Carlos Town Board of Supervisors has met and heard and passed all objections to the proposed assessment for the improvement of Ida Pines Lane by bituminous surfacing.

NOW THEREFORE, BE IT RESOLVED BY THE CARLOS TOWNSHIP BOARD OF SUPERVISORS, DOUGLAS COUNTY, MINNESOTA;

- 1) Such proposed assessment, a copy of which is attached hereto and made a part of hereof, is hereby accepted and shall constitute the special assessment against the lands named therein, and each tract of therein included is hereby found to be benefited by the proposed improvement in the amount of the assessment levied against it.
- 2) Such assessments shall be payable in one of two ways: paid in full to the clerk on or before November 25, 2018; or by installments extending over a period of 5 years, the first of the installments to be payable on the residents property taxes beginning in May 15, 2019 and shall bear an interest of 8 percent per annum from January 1, 2019. To each subsequent installment when due interest will be added for one year on all unpaid installments.
- 3) At any time during the 5 year time span, the resident may contact the clerk and pay off the full remaining balance with no interest to be charged the remaining years.
- 4) The clerk shall forthwith transmit a certified duplicate of this assessment to the county auditor to be extended on the property tax list of the county. Such assessments shall be collected and paid over in the same manner as other municipal taxes.




WHEREAS, pursuant to proper notice duly given as required by law, the Carlos Town Board of Supervisors has met and heard and passed all objections to the proposed assessment for the improvement of South Lake Miltona by a cluster septic system.

NOW THEREFORE, BE IT RESOLVED BY THE CARLOS TOWNSHIP BOARD OF SUPERVISORS, DOUGLAS COUNTY, MINNESOTA;

- 1) Such proposed assessment, a copy of which is attached hereto and made a part of hereof, is hereby accepted and shall constitute the special assessment against the lands named therein, and each tract of therein included is hereby found to be benefited by the proposed improvement in the amount of the assessment levied against it.
- 2) Such assessments shall be payable in one of two ways: paid in full to the clerk on or before November 25, 2018; or by installments extending over a period of 10 years, the first of the installments to be payable on the residents property taxes beginning in May 15, 2019 and shall bear an interest of 2 percent per annum from January 1, 2019. To each subsequent installment when due interest will be added for one year on all unpaid installments.
- 3) At any time during the 10 year time span, the resident may contact the clerk and pay off the full remaining balance with no interest to be charged the remaining years.
- 4) The clerk shall forthwith transmit a certified duplicate of this assessment to the county auditor to be extended on the property tax list of the county. Such assessments shall be collected and paid over in the same manner as other municipal taxes.
