

MINUTES
CARLOS TOWN BOARD
Regular Meeting, September 24, 2020 Carlos Town Hall

Chairman Meyers called the meeting to order at 7:00 PM with all reciting the Pledge of Allegiance.

Board Members attending: Rod Meyers, Bill Krivanek, Mark Hintermeyer, and Rebecca Anderson.

Guest attending: No guests.

Bill Krivanek moved to approve the minutes of September 8, 2020 as printed. Mark Hintermeyer seconded the motion and it carried unanimously.

Zoning: The Kjos application was approved.

Committee reports: Mark Hintermeyer met with the City of Carlos in regard to transferring CARE funds to the city. There are new guideline rules that indicate changes in the transfer of monies. The city is not allowed to receive funds, however, the township can purchase the needs for the first responders or fire department. The city clerk gave the township contact numbers for these two entities.

Old business: The board received information that the township can lower the speed limit on township roads from 55 mph. Bill Krivanek will look to write a policy draft the township will need going forward, as there are many roads in the township that would qualify for this change.

The reflectors on the east side of the Miltona Carlos Bridge is missing. Chairman Meyers will check with the county to see if they have these reflectors as they constructed the bridge.

Interlachen Drive residents are now indicating they would like to have their road paved. Chairman Meyers told the residents who inquired on this, they would need to have a petition of 35% of landowners. The township has attempted on two separate occasions to pave this road. However there was huge opposition from landowners.

Bill Krivanek indicated the repair on Bluffs Road has not been started. Chairman Meyers stated it is on Mark Lee's agenda.

The Alexandria Chamber of Commerce would like to change a lodging tax. The township is not interested in participating. The clerk will inform the Chamber of this position.

The clerk received the allocation for ALASD's levy for 2021. The amount indicated is based on a formula. The township's ALASD fund has been receiving monies through the county that continue to grow even though the township pays the levy amount. Bill Krivanek will check with ALASD to see why this continues to happen.

The board reviewed building permits.

Dave Rush has not looked into the issue of how the township can be made aware of property exchanges that are in the South Lake Miltona Sewer District.

The public access road located off East Lake Carlos Drive and Prairie Road is in need of repair. After viewing the road, it was assessed the damage is due to garbage trucks making turns at the intersection at the bottom of the hill. The board advised the clerk to send a letter to the residents and garbage haulers that the road will be repaired, however, residents will have to bring their receptacles to the intersection. The haulers will be required to back down the road versus going forward and make turns at the intersection.

There being no further business, Bill Krivanek moved to adjourn at 7:52 PM. Mark Hintermeyer seconded the motion and it carried unanimously.
