

MINUTES
CARLOS TOWN BOARD
July 22, 2021 Carlos Town Hall
Regular Meeting

Board Members attending: Supervisors Rod Meyers, Bill Krivanek, Dwayne Waldorf, and Clerk Rebecca Anderson.

Guest attending: Steve Chojnacki

Chairman Meyers called the meeting to order at 7:00 PM, and led the board with reciting the Pledge of Allegiance.

Dwayne Waldorf moved to approve the minutes of July 6, 2021 as corrected. Bill Krivanek seconded the motion, which passed unanimously.

Steve Chojnacki addressed the board with continued concerns in regard to his neighbor's dispute with his family. His neighbor is stating their portable basketball hoop in the township ROW, which he believes should not be allowed by the township. Mr. Chojnacki indicated they move the hoop up to the house during the winter, then out to the ROW during the summer. They have been doing this for the past 15 years. His property is on the dead end and by placing the hoop in the ROW poses no obstacles to anyone. He also stated that his neighbor has at least five structures in the ROW, such as a flower garden. The township has no issues with Mr. Chojnacki's basketball hoop. This is a neighbor conflict and the township will not be involved.

Zoning: There was nothing to report.

Committee Reports: There was nothing to report for Carlos Township, however, Miltona Township is looking for grants or loans to help with the cost for the Krohnfeldt Road project.

The board reviewed the bill from Scott Johnston in regard to the Dahlen Quiet Title.

Clerk Rebecca Anderson reported the issue with the Davis property on CR11 is closed as this was a county issue, not the townships.

The board reviewed the ROW issue by the public access off of East Lake Carlos Drive. The clerk indicated she had spoken with Mr. Torguson and he is happy to work with the township on signing over part of his property to the township for right of way. Chairman Meyers will contact Scott Johnston and have him draw up documents for this transfer of property.

The annual meeting held in March was recessed to August 12, 2021 at 7:00 PM to set the road and bridge levy for 2022. The regular meeting will follow this meeting.

Chairman Meyers informed the board the Alexandria School District and the City of Carlos have reached an agreement to lease property to the city for the building of a fire hall. Chairman Meyers will inform the city that the township board will want to take part in drawing up plans.

Road Issues: Chairman Meyers signed the proposal for the selected 2021 road projects with Mark Lee. The county has the road signs for Prairie/Pike Road. The board will look at spraying brush for 2022.

The board reviewed building permits.

The District 9 Meeting will be held August 16, 2021 at 7 PM in Pelican Rapids.

The City of Carlos is in charge of the School District 206 School board primary to be held on Tuesday, August 10, 2021. The election will be held at the Carlos Town hall and will include the City of Carlos, Carlos and Bell River Townships. The polls will be open from 7:00 AM to 8:00 PM.

The clerk will contact the South Lake Miltona Focus group and set up a date/time for their annual audit to be held in August.

There being no further business, Bill Krivanek moved to adjourn at 8:11 PM. Dwayne Waldorf second the motion and it carried.
