

**MINUTES**  
**CARLOS TOWN BOARD**  
**October 14, 2021 Carlos Town Hall**  
**Regular Meeting**

Board Members attending: Supervisors Rod Meyers and Dwayne Waldorf. Clerk, Rebecca Anderson and Treasurer, Tammy Schwegel. Bill Krivanek was absent.

Guest attending: Carol Weber Brown

Chairman Meyers called the regular meeting to order at 7:00 PM with all reciting the Pledge of Allegiance.

Dwayne Waldorf moved to approve the minutes of September 23, 2021 as printed. Chairman Meyers seconded the motion, which carried.

Guest Carol Weber Brown was attending the meeting to learn more about the process of township meetings.

Road Issues: Dwayne Waldorf asked Dave Luedeke with R&R if there was a schedule for blading roads. Dave indicated they blade the roads after a rain or if the board makes requests to have all or certain roads graded. Road issues on North Riverview and Judicial Ditch were discussed. Joe Zunker, 911 coordinator official with the county, emailed the clerk indicating Emerald Lane should be signed Emerald Terrace NE. Also it was brought to the attention of the board that North Park Drive should be North Park Road. The clerk will order new signage.

Dwayne Waldorf moved to pay R&R their bill for October. Chairman Meyers seconded the motion and it carried.

Zoning: Central Lakes Storage LLC's new application was approved.

Committee Reports: Dwayne Waldorf gave an update on ALASD: ALASD will be going after carp on Lake Winona; there is interest from a private party to purchase property on HWY 27; Construction on West Lake Cowdry and the west side of Miltona will begin shortly; rates for next year will increase by approximately \$3.00 per month and his appointment is up at the end of the year.

COVID application: Treasurer Tammy Schwegel submitted the application for additional COVID funding.

Steve Henry asked to be placed on the agenda for the October 28<sup>th</sup> meeting. He would like to discuss if using COVID funds is a possibility for water quality issues.

Road Issues: Dwayne Waldorf received a few calls: one being a security light removed on Birchwood Terrace; and second, Alan Roebke would like brush and trees removed 17 ½ feet from the center lane (in the ROW) so he can move a house safely on Tolena Road.

Larry Steidl will be cutting a tree down in the ROW on Sandhill Lane (Brinks). If there are any other trees to be cut down, this would be at the cost to the landowner.

Road Issues: Chairman Meyers indicated road work will begin next week on Mount Carmel.

Tammy Schwegel presented the board with the Treasurer's report. Dwayne Waldorf moved to approve the report as presented. Chairman Meyers seconded the motion and it carried.

Chairman Meyers presented the bills for October, 2021. Dwayne Waldorf moved to pay bills in the amount of \$10,566.28. Chairman Meyers seconded the motion and it carried.

The board reviewed the Newsletter – November 2021 with no changes.

The board viewed building permits.

There being no other business, Dwayne Waldorf moved to adjourn at 8:11 PM. Chairman Meyers seconded the motion and it carried.
