

CARLOS TOWN BOARD
July 24, 2025 - Carlos Town Hall
Regular Meeting

Board Members attending: Supervisors, Rod Meyers, Dwayne Waldorf, and Bill Krivanek along with Clerk, Rebecca Anderson.

Guests attending: None.

Chairman Meyers called the meeting to order at 7:00 PM with all reciting the Pledge of Allegiance.

Bill Krivanek moved to approve minutes from July 10, 2025 as printed. Dwayne Waldorf seconded the motion that carried unanimously.

Zoning: There will be viewing Friday, August 1st for the August 11th Planning Commission meeting. Dwayne Waldorf will attend.

Community Report: There will be a Joint Powers meeting on Monday, July 28th. Bill Krivanek will be meeting with an attorney to find out the cost of issuing a new Joint Powers Agreement that would have the entire fire district be the bonding agent vs only Carlos Township. Alexandria city officials, Jeff Karrow and Marty Schultz would like to meet to view changes to fire district boundaries. Bill Krivanek will wait to meet with the two men, then see if dispatch needs to be included.

Special Meeting: Dwayne Waldorf moved ^{to} approve Resolution 2025-3: Setting the date for Special meeting to address a levy change for the monies already spent for the fire district. Bill Krivanek seconded the motion and it carried unanimously. The date is September ³~~2~~, 2025 at 7:00 PM at the Carlos Event Center. The clerk will publish and post this notice. ⁴

Sailor Crossing: The clerk is to send a letter to all residents of this development that they are to remove all recreational vehicles from the township road. Those vehicles are not to be parked on the road, but are to be moved to their driveway or property as this is a public safety issue.

Road Issues: the sign for North Riverview was ordered. The board received a quote from Stennes Excavating for the rebuild of Judicial Road. Chairman Meyers will speak with the contractor as there are line items listed the board feels are not necessary. There is also no quoted price for removing trees in the 2 rod road right of way. The award is tabled at this time.

Mike Gustafson contacted a board member to have a tree cut back at the T intersection of South Park Drive past the dam and next to the lake. The clerk will contact the state park to see if they will take care of it.

The common green area in the South Riverview development has been torn up by someone driving 4-wheelers. The board will conduct an investigation to see if the perpetrators can be identified. The sheriff will be monitoring the area.

There were no building permits to review.

There being no other business, Bill Krivanek moved to adjourn at 8:40 PM. Dwayne Waldorf seconded the motion and it carried unanimously.
