

CARLOS TOWN BOARD
August 14, 2025 - Carlos Town Hall
Regular Meeting

Board Members attending: Supervisors, Dwayne Waldorf, and Bill Krivanek along with Clerk, Rebecca Anderson and Treasurer, Tammy Schwegel. Rodney Meyers was absent.

Guest attending: David Kjos.

Vice-Chairman Waldorf called the meeting to order at 7:00 PM with all reciting the Pledge of Allegiance.

Bill Krivanek moved to approve minutes from July 24, 2025 as corrected. Dwayne Waldorf seconded the motion that carried.

Road Issues: David Luedeke with R&R asked the board to review if they want him to mow the township ROW for an additional time. Usually the ditches are mowed twice a year, (early summer and fall) however, he felt with all the rain this summer, perhaps the ditches should be mowed for an additional time. He was notified of a dead cottonwood tree on Bay Lane. The clerk will check to see if the tree is in the ROW and get back to the board.

Bill Krivanek moved to pay R&R their bill for August. Chairman Waldorf seconded the motion and it carried.

Dave Kjos wanted to know what would be discussed at the September 4th Special Meeting. The meeting will be held for residents to vote to add approximately \$250-\$300,000 to the 2026 levy. This would cover the amount already spent on engineering fees for the proposed Fire hall, along with expected costs for upcoming additional engineer costs.

There may be discussion on the proposed fire hall, however, there will not be any decisions on this issue.

Zoning: There will be a viewing Friday, August 15th for the Hintermeister application for a gravel pit on Prairie Road. Vice-chairman Waldorf will attend this viewing.

Committee Reports: Vice-chairman Waldorf gave an update on the cost of the expansion for the ALASD facility. The Joint Powers for the fire hall did not meet.

Clerk, Rebecca Anderson indicated there will be an election on November 4, 2025 for School District 206's referendum. All costs will be covered by the school district. Belle River Township, the City of Carlos and Carlos Township residents will be voting at the Carlos Event Center.

Road Issues: Letters to residents of Sailor Crossing went out in regard to residents parking recreational vehicles on the township road. Also, it appears the issue with the 4-wheelers that tore up an area in South Riverview has stopped.

Treasurer, Tammy Schwegel presented the financial report for the month ending July 31, 2025. Bill Krivanek moved to approve the report as presented. Dwayne Waldorf seconded the motion which carried. She will cash in the \$100,000 CD that comes due August 17th.


